<b>Qualifications of the Applicant</b>	<ul style="list-style-type: none"> <li>√ Pharmacy provides pharmacy services to post acute facilities, skilled nursing facilities, assisted living communities, intermediate care facilities, and/or group homes</li> <li>√ Pharmacy is in good standing with the applicable Board(s) of Pharmacy(ies)</li> <li>√ Owner and/or Pharmacy Manager is an ASCP member in good standing</li> <li>√ A single pharmacy unit or corporation with multiple sites</li> <li>√ Pharmacy can demonstrate a history of exceptional service and/or innovative solutions to the population(s) it serves</li> </ul>
